Important Cuxton Parish News

The Boundary Commission is responsible for national and local government boundaries and ensuring that within these boundaries voters are represented fairly. This year the Boundary Commission have looked at Medway Wards and have identified that Cuxton and Halling Ward are underrepresented by 39%. This prompted a public consultation that began last year. Ninety-nine residents and Cuxton Parish Council responded to the consultation and the Boundary Commission commented positively on the strength of the responses from both Parish Councils and individual residents. However, they have concluded that there are too few residents in Cuxton and Halling for it to be a two Councillor Ward. Staying with one Ward Councillor will not be allowed because Cuxton and Halling residents would remain seriously underrepresented.

Cuxton Parish Council were dismayed that the new Ward boundary proposed by the Boundary Commission extends from Halling to Rochester Bridge and includes a large part of Strood South. This new Halling, Cuxton and Strood Riverside Ward would have three Councillors and include parts of a number of roads currently in Strood South, for example, Maple, Sycamore, and Cedar Road.

Having three Ward councillors may seem a good thing, however, the Parish Council feel that there are significant disadvantages associated with being joined to a large urban area. The main concerns are that it may impact on the rural status of Cuxton and Halling; may make it more difficult for the smaller voice of Cuxton to be heard, and the lack of common concerns between the two communities (rural and urban) that may well lead to conflicts of interest for the three Ward Councillors.

The Parish Council believe that if two ward Councillors for Cuxton and Halling Ward is not possible then linking Cuxton and Halling with Medway Gate and/or the Temple Wharf housing developments would be an acceptable compromise. More than 40% of the children attending the Academy of Schools come from Medway Gate and have links with other organisations and family based in Cuxton. We believe this proposal will result in a solution that meets the minimum number of electorate for two Ward Councillors.

You will find a copy of the Parish Council full response to the Boundary Commission Proposal in the village noticeboards and on the Cuxton Parish Council and ACT websites. Links to these sites will be made available on social media. The next consultation closes on 7th September and the Parish Council would encourage residents to read the Boundary Commission Report (p. 12-14) and the Parish Council response before responding to the consultation by accessing the Boundary Commission website and selecting Medway from the list of consultations. By adding your views to this consultation the voice of Cuxton will be heard.

Children's Play Area

As most of you will know, the children's play area in the recreation ground has been closed since March as a result of the Covid19 lockdown. At the beginning of July, the government issued guidance on how play areas could be opened safely. Unfortunately the Parish Council do not have the resources to meet the government guidelines for monitoring and cleaning the play equipment. Discussions with the Council's public liability insurance provider raised concerns that opening without the necessary guidelines in place would mean our public liability insurance would be invalidated.

Since that time, we have completed the necessary risk assessments and have been liaising with our

insurers and other relevant bodies, to ensure that we are able to open safely. As a result the Council were pleased to be able to open the playground on Wednesday 5th August but were disappointed not to have been able to do so sooner. We hope residents understand that it would have been reckless of the Council to open the playground without public liability insurance.



The Council stress that the playground is not regularly monitored or cleaned, so users should be aware of this and ensure that they read the advice notices on the playground entrance, have hand gel for their children to use before and after using the equipment and observe social distancing.

On another note.

We are in the process of upgrading the play area. The safety surface is due to be repaired soon and some new equipment has been ordered. The latest playground inspection report has identified the need to re-paint the playground fencing in order to prevent the fencing deteriorating. As a consequence we are looking to get a group of volunteers together to rub down and paint the play area fences over the summer. 
A list of rules for the track have been formulated to advise users how to keep themselves safe and sound, the most
